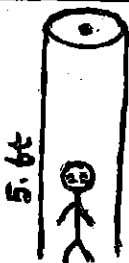

4.37 P.M. Stood pure Memory form.

Now to advise here because being the first original subject.
For the last 3 or 4 days this level did not work.

Then she had Pure Memory touch and from that level she
began to repeat the subject, from Jan 22nd - 1.30 P.M.

9.47 P.M. C.V. began to consult.

Owing some disturbance in the stomach postponed.

29.1.1921 Saturday 10.27 A.M. Advice:-

Gaseous figure and the Etherie from the returns as in outer Etherie and in inner gaseous figures and standing at the bored point vibrates to the Physical figure through the route it has taken.

This begins to work in the Self body which has no stability & Etherie, and it acts in 360° where no Kundalini & gaseous figure in the House portion.

By this 4 Dead occurances has been tried.

1. K, 2. Stability, 3. Gaseous state and 4. Etherie. These 4 focussed as one with wanting of Prana and bores the wanters Prana level. Prana quality is to fill up. Then went to meals. 11.40 A.M.

7.20 P.M. Consulting:- Now she says that she saw the Master and has reported all that has occurred yesterday. She should not be left without proper guidance and not to commit the same.

B.S.K. was asked to and was regulated.
7.30 P.M. C.V. has committed a mistake in 100 divisions
of M.T.A. in Fourth Round.
