Those who are practising with full confidence and faith with belief, surrendering their whole life and family with implicit obedience are guarded by the Direct line Origin.

Within 10 years they stand so as to distribute aura and will have Life activity flow in Brain portions, and in the course of the progress treatments etc. could be able to use.

These should promise with strong determination that they would attend whenever Master asks them to work, to go whenever he bids, to do whatever he bids, without caring his dignity or convenience or loss.

This development is to observe how it works in a year and half period.

This practice should be done in a dark place. It will give postures and currential actions in the system.

Now a selection will be made from old mediums who have sight to this kind of development. But this will give a sort of half-handed unconscious state after the practice or at times in a little uncontrollable manner. Once in 45 days the breathing will have a change and could be noted.

Bloated body is not fit for this. If they are trained lifts will be given in treatment, materialising etc.

To get a medium to this development is rather a difficult one and so after having a selection, further instructions will follow.

The General advice for Treatment.

1. Only the selected mediums are empowered to treat the diseases.
2. It is permitted to treat for the present the diseases caused by Bre. No.1 to 10 and 26 to 30.
3. The operator will have to note at first his own Breathing No. at the commencement and should treat the cases that fall within his Bre. No.
4. In treating the patient, after the namaskaram the process should begin in his system from K. Instead of that if the operator feels flow from top, he is to wait for 3 or 4 minutes and should observe whether the process begins from K. If not, he is to stop the treatment.
5. While treating, the patient should feel the actions in all affected parts but should he feel them only in some portions those alone are curable.

The rest of the affects are due to other breathings that should be noted and to treat after

the present complaint is relieved.

6. A. If the operator and the patient are sympathetic the effect is sure.

B. If the patient is unsympathetic the delay in cure will ensue.

C. If the operator is weak and the patient is unsympathetic the result is nil.

7. While treating the patient the operator is affected with any deceases, the same will be rectified by continuing the treatment.

The above symptom may be either due to excessive heat or his own disease in rectification.

8. If the disease is too severe for the operator to stop the treatment for a day or two and then to proceed.

9. The operator on any account should not subject himself to excitement, neglect of health, wanderings, irritations, and fastings, but should maintain a calm and pleasant mood with firm faith and belief in the Master's advice.

10. For chronic cases treatment for a month at least generally will produce the desired effect.

11. Permission is granted to treat only wife, children and co-mediums.

12. In cases of emergency the relations could be treated by special permission from the Master.

13. Permitted to cure Scorpien stings chilvisham (செவ்வாலை) (Tamil) and sprains for all.

14. Permitted to attend the patient in moffussil provided the patient bears the travelling and batta charges.

15. For every acute form of diseases three days process are necessary (2 process daily) and in cases of emergency one process extra at noon.

16. Remuneration of any kind on no account should be accepted. If offered voluntarily the fact should be reported to the Master.

17. While attending the female patients the operator should be 4 feet away from the patient and to do the process in the presence of the husband or any other nearest relative.
18. While attending the patient in their houses take rest for 10 or 15 minutes and then begin the process.
19. After the treatment is over the operator should give advices if any and to avoid all occasions for chat or gossips.
20. On any account even the symptoms are worse don't discourage the patient or his relations,
21. The patient should as a rule supply some refreshment if necessary to the operator if the latter attends the patient at his house, or even if the patient goes to the operator for treatment.
22. Points to be noted. :-
 1. Name and address, age.
 2. Complaint.
 3. Breathing No.
 4. Diagnosis (secret)
 5. No. of process and the result.
23. To maintain equanimity of temper towards your enemy during treatment when help is sought by them.
24. Without minding your own convenience render instant help.
25. For Dysentary ask them to repeat "Coolden waking activity etc." 5 or 6 times according to the nature of the affect.
26. Don't compel others to seek your help in treatment.

" TREATMENT ADVICE "

1. To note the Bre.No. of the operator first.
2. Then to take Bre.No. of the patient and the date of its beginning.

3. To examine the whole system and to note the organs affected and its cause.
4. Then to treat as per advice.
5. To instruct the patient to attend at the fixed hours and about the diet.
6. To examine the system every third day or according to the nature of the disease and to note the progress.
7. If there is no improvement, at once to report to the Master and to suspend the operation.
8. There should be no break in the treatment and the operator should not leave the patient on any account in the middle nor should the patient attend the treatment irregularly.
9. Non observance of any of the rules shall be punished with 6 months banishment from the Society.
10. The operator on any account should not reveal the diagnosis or the principles of working or any secret concerning the soul either to the patient, relative or doctors.
11. Neither the operator nor the Patient should not have empty stomach at the time of operation.
